

## Simpson Thacher Represents Initial Purchasers in Cinemark's Debut Secured Notes Offering

The Firm recently represented the initial purchasers in connection with Cinemark USA, Inc.'s private placement of \$250 million aggregate principal amount of 8.750% Senior Secured Notes due 2025. The notes are guaranteed on a joint and several senior basis by certain subsidiaries of Cinemark USA, Inc. Cinemark USA, Inc. intends to use the net proceeds from the senior secured notes offering for general corporate purposes, including further increasing its liquidity.

Cinemark USA, Inc. operated a total of 554 theaters and 6,132 screens in the United States and Latin America as of December 31, 2019.
