

## BREIT to Acquire WPT Industrial Real Estate Investment Trust for \$3.1 Billion

The Firm is representing Blackstone Real Estate Income Trust in connection with its acquisition of WPT Industrial Real Estate Investment Trust in an all-cash transaction valued at US\$3.1 billion. Completion of the transaction, which is currently expected to occur in the fourth quarter of 2021, is contingent upon customary closing conditions, including the approval of WPT's unitholders.

WPT is a Canadian real estate investment trust that acquires, develops, manages and owns distribution and logistics properties located in the United States. WPT's operating subsidiary indirectly owns or manages a portfolio of properties across 19 U.S. states consisting of approximately 37.5 million square feet of GLA and 109 properties.

The Firm has represented Blackstone in three multi-billion dollar take private transactions during the past five months.
